<p>Monday, March 15</p>	<p>9:30 a.m. ET: School officials can access <i>Unmatched Applicants</i> report in the R3 system (embargoed until 10 a.m. ET)</p> <p>10 a.m. ET: Supplemental Offer and Acceptance Program (SOAP) begins</p> <ul style="list-style-type: none"> • Applicants learn if they matched (by courtesy email and R3 system) <ul style="list-style-type: none"> ◦ SOAP-eligible unmatched and partially matched applicants can access the <i>List of Unfilled Programs</i> in the NRMP's R3 system under the SOAP tab, which will appear at the start of SOAP. NRMP is the authoritative source for applicant SOAP eligibility. The <i>List of Unfilled Programs</i> will show only programs for which the applicant is eligible based on their matched status. Each application service will display all the unfilled programs using that service for SOAP. Applicants are responsible for ensuring they apply only to positions for which they are eligible, as shown on the SOAP <i>List of Unfilled Programs</i> in the NRMP's R3 system. • Programs learn if they filled by courtesy email and logging in to the R3 system • Medical schools receive <i>List of Unfilled Programs</i> by courtesy email and logging in to the R3 system <p>11 a.m. ET: SOAP applicants can start preparing applications in the application service or process required by the program. The application service required by the program will be listed on the SOAP <i>List of Unfilled Programs</i>. Applicants and their representatives CANNOT communicate with a program until contacted by that program.</p>
<p>Tuesday, March 16</p>	<p>8 a.m. ET: Programs begin reviewing SOAP applications via their designated application service. Programs may contact applicants upon receipt of an application and begin interviewing.</p> <ul style="list-style-type: none"> • SOAP-Ineligible applicants can apply to and contact non-SOAP-/non-Match-participating programs. <p>11:30 a.m. ET: Programs may begin creating SOAP preference lists in the R3 system. Applicants do not submit a preference list for SOAP.</p>
<p>Wednesday, March 17</p>	<p>Programs continue reviewing applications, conducting interviews, and creating/certifying SOAP preference lists in the R3 system.</p>

9 a.m. ET: Applicants receive round 1 offers by logging in to the R3 system

9 a.m. ET: Medical schools can view the *SOAP Schools Report* (updated in real time) to track students/graduates.

11 a.m. ET: Applicant deadline to accept/reject round 1 offers

Applicants can begin contacting all remaining unfilled programs. Programs can update the <i>List of Unfilled Programs</i> as positions are filled.
